Use this form to establish checkwriting privileges for your fund accounts that offer this service. This option is available only for money market funds and for bond funds other than Vanguard Emerging Markets Bond Fund, Vanguard Emerging Markets Government Bond Index Fund, Vanguard High-Yield Corporate Fund, Vanguard Prime Money Market Fund Admiral™ Shares, and Vanguard Total International Bond Index Fund.

1. Funds you'd like to write checks on

This form should only be used to establish checkwriting on your 11-digit mutual fund account. If you wish to establish checkwriting on your 8-digit Vanguard Brokerage account, please utilize the Vanguard Brokerage Account Checkwriting Form (BCWBT).

Note: In most cases, either Vanguard's default cost basis method (average cost) or your preferred cost basis method for this fund and account will be used for checkwriting-initiated transactions. However, if your preferred method is the specific identification method, the first in, first out (FIFO) method will be used instead. Vanguard Personal Advisor Services accounts may have a different default cost basis method; please consult your financial advisor for more details.

2. Signature(s) of account owner(s)

I authorize Vanguard's custodian bank to honor checks drawn by me on the Vanguard fund account(s) listed in Section 1 and to effect a redemption of sufficient shares on the account(s) to cover payment of such checks. I understand that:

- This privilege may be amended or terminated at any time by the fund or the bank, and neither shall incur any liability to me for such amendment or termination, or for honoring such checks, or for effecting redemptions to pay such checks, or for returning checks that have not been accepted.
- No check shall be issued or honored, or redemption effected, for any amounts represented by shares unless payment of such shares has been made in full and any checks given in such payment have been collected through normal banking channels.
- This privilege is subject to all the terms and conditions stated in the fund's prospectus.

I understand that if I've established a full agent on any account(s) listed in Section 1, that full agent must also sign this form.



This applies to IRAs only. > If I'm establishing checkwriting on an IRA, I certify that I'm age 59½ or older and I elect not to have federal and state income taxes withheld from my IRA checkwriting distributions. I understand that I'm responsible for paying any taxes due on my IRA checkwriting distributions. I understand that I may be responsible for paying estimated taxes on my IRA checkwriting distributions, and if my estimated tax payments are insufficient, I may incur penalties.
